

CHANDIGARH ADMINISTRATION: SPORTS DEPARTMENT

ORDER

Shri Nand Lal Verma S/O Shri Dila Ram Verma, H. No. 3203, Sector 21-D, Chandigarh, is hereby appointed as Junior Handball Coach (OBC Category) purely on temporary basis against a vacant post with immediate effect, in the pay scale/matrix of Rs.35,400/- as per 7th Central Pay Commission adopted by Punjab Government vide letter No. 7/42/2020,SFP1/741-746, dated 17-07-2020 duly adopted by Chandigarh Administration vide No. 7000/1/2-F&PO(7)-2020/12240, dated 17-09-2020 and further conveyed by Department of Finance, Chandigarh Administration vide their U.O. No. 7000/1/44-F&PO(7)/2021/1940, dated 18-02-2021.

He will be paid minimum as per pay matrix of 7th Central Pay Commission of the post or D.C. rate whichever is higher from the date of joining during the period of probation. Other allowances shall be admissible after the successful completion of probation period.

His appointment is further subject to the following terms and conditions:-

1. That he is appointed against a purely temporary post.
2. That before joining against said post he has to produce:-
 - a. Medical Fitness Certificate from the Principal Medical Officer, Govt. Multi- Specialty Hospital, Sector-16, Chandigarh.
 - b. An Affidavit that he has only one living spouse.
 - c. Character and antecedents are to be verified by the concerned authorities.
 - d. Undertaking of oath of allegiance to the Constitution of India.
3. That his appointment is subject to the verification of academic qualification, caste certificate. If the verification reveals that the academic qualifications/caste certificate found to be false then his services will be terminated forthwith without prejudice to such further action.
4. He will be on probation for a period of three years. If the work and conduct is not found satisfactory during the period of probation, his probation period can be extended.
5. As per letter issued by the Department of Personnel & Training, Chandigarh Administration vide No. 28/69-IH(12)-Pers.Trg.2019/17927, dated 25-11-2019, ICT Skills courses are mandatory for all fresh recruitment (Entry level) and for promotion/grant of benefit under Assured Career Progression Scheme (ACPs) to all Group 'A', 'B', 'C' & 'D' employees of the Chandigarh Administration.
6. He will be governed by the rules and regulations as applicable to the employees of Chandigarh Administration.
7. He will be governed by New Pension Scheme (NPS) Scheme.
